The deduction will automatically continue unless a change is made. Christmas Club accounts for 2013 will be automatically transferred to your credit union savings account on October 1, 2013.

- 3) Before 2:00 PM at the Annual Meeting of the credit union in the Sabin Education Center, 2nd Floor.

You must register your ballot by signing a shareholders list at the time you cast your vote, (whether cast at or before the Annual Meeting).

After a short business meeting, the results of the election of the Board of Directors will be announced and the drawing for prizes will be held.

All members, 18 years of age and over who vote, will be entered in the drawing.

KIDNEY CARS PROGRAM PUTS THE GOOD IN GOODBYE

It is time to say goodbye to your old vehicle. Ease your separation anxiety by donating your unwanted vehicle to a program that will help save lives and possibly make you eligible for a tax deduction. Through the National Kidney Foundation of Ohio, Kidney Cars Program, area residents can make one simple phone call and have their car, truck, van, motorcycle, boat, trailer or RV driven or towed away free of charge. This may qualify for a federal income tax deduction of the vehicle's fair market value. Vehicles can be running or in non-running condition, and must have an accompanying title. Contributed vehicles will be either resold or recycled with the net proceeds benefiting the NKF's programs in patient services, medical research, public and professional education and organ donation awareness. The Kidney Cars Program is a continuous campaign helping Ohio residents and associations clean up neighborhoods by recycling unwanted vehicles and eliminating environmental hazards.
